**AGREED ORDER MODIFYING NOTICE DEADLINE IN
PRELIMINARY APPROVAL ORDER**

This matter, coming before the Court by agreement of Class Representative Eric Zepeda and Defendants Intercontinental Hotels Group, Inc. and Kimpton Hotel & Restaurant Group, LLC (collectively, the "Parties"), and the Court being fully advised and for good cause shown, IT IS HEREBY ORDERED:

1. On July 31, 2018, this Court entered an Order granting Plaintiff's motion for preliminary approval of a class action settlement agreement (the "Preliminary Approval Order").
2. Under the Settlement Agreement, notice is being provided to class members through a combination of email and U.S. Mail. Pursuant to the Preliminary Approval Order, notice is to be completed by August 14, 2018.
3. Defendants experienced some technical difficulties in gathering and finalizing the class data, including names and contact information, to be provided to KCC,

the Settlement Administrator, such that notice will not be able to be completed by August 14, 2018.

4. The Settlement Administrator now has the class data and is working to disseminate notice by email and U.S. mail, and will be able to disseminate notice no later than August 21, 2018.

5. No other deadlines need to be modified at this time.

6. For good cause, the Court hereby modifies the Preliminary Approval Order to extend the Notice Date by seven (7) days, to August 21, 2018.
