## AGREED ORDER TO MODIFY DEADLINES IN PRELIMINARY APPROVAL ORDER

This matter, coming before the Court by agreement of Class Representative Eric Zepeda and Defendants Intercontinental Hotels Group, Inc. and Kimpton Hotel & Restaurant Group, LLC (collectively, the "Parties"), and the Court being fully advised and for good cause shown, IT IS HEREBY ORDERED:

- On July 31, 2018 this Court entered an Order granting Plaintiff's motion for preliminarily approval of a class action settlement agreement (the "Preliminary Approval Order").
- 2. On August 15, 2018, in light of difficulties in transferring class data to the Settlement Administrator, this Court entered an Order extending the time for class notice to be completed from August 14, 2018 to August 21, 2018.
- Following such initial delays and further technical difficulties in gathering and finalizing the class data, the Settlement Administrator is now in a position to commence class notice and administer the settlement.

- 4. As a result, the Parties require a minor modification to the deadlines contained in the Preliminary Approval Order. Although the dates will be changed, the actual time elapsed between the respective events remains consistent with the prior Preliminary Approval Order.
- 5. For good cause, the Court hereby extends the deadlines contained in the Preliminary Approval Order as follows:

a. Notice to be completed by:

**September 21, 2018** 

b. Fee and Expense Application:

October 16, 21018

c. Objection Deadline:

**November 6, 2018** 

d. Exclusion Request Deadline:

November 6, 2018

e. Final Approval Submissions:

November 21, 2018

f. Final Approval Hearings:

December 5, 2018 at 10:30a.m.

g. Claims Deadline:

December 5, 2018
